I. PROCEDURAL

The meeting was called to order at 12:04 PM.

II. AGENDA

IV. BUSINESS ARISING

1. Transit Planning - Presentation

Since new commissioners are expected in the coming weeks, the presentation has been deferred until January 2026 to ensure all members can participate.

2. Terms of Commissioners

At present, the Commission has a vacant Council Representative position. As of the end of December, Commissioners Smee and Hutchens will have completed their first term and Commissioner Akerele will have reached her maximum years of service.

A request will be sent to the City Clerk with the following actions which will return the Commission to a full complement:

- Councillor to replace Maggie Burton;
- Decision by Council on Ron Ellsworth's position;
- Renew Josh Smee and Derrick Hutchens, who have both indicated their interest in continuing to serve on the commission, for a second two-year term; and
- Advertise for a new public member to replace Tolulope Akerele.

A subcommittee will be convened after the submission deadline to review applications for the new public member position.

V. NEW BUSINESS

1. 2025 Goals Update

An update was provided on the status of Metrobus' operational goals for 2025. These goals are included as part of the City's strategic plan.

Completed projects include:

- Addition of two new wheelchair accessible routes
- purchase of 8 new hybrid buses
- Installation of 37 solar panels on bus shelters
- Implementation of planned service improvements in June and September
- Upgrade of fare collection and smart card systems

Other projects, such as depot upgrades to support the transition to zero emissions buses, introducing new accounting and HR software, and adding new bus shelters are progressing, while a few others, including the stop announcements system are experiencing delays.

The Commission expressed interest in doing a news release or advertising campaign to publicly highlight Metrobus' achievements on a regular basis. This will be taken back to staff for development.

2. Reports

i. General Manager's Report

The Commission acknowledged the General Manager's appointment to the Board of Directors for CUTRIC (Canadian Urban Transit Research and Innovation Consortium). CUTRIC is a non-profit organization that creates technology and other projects and initiatives that advance decarbonized and autonomous public transit systems. CUTRIC has supported many public transit agencies, including Metrobus, in preparing for electrification.

ii. Executive Summary Report

CUTA published a documentary about the challenges faced by front-line transit employees in dealing with issues like addiction and homelessness, and the approaches used to help address the issues. The documentary was shared among managers and supervisors. It was helpful to know that staff in other transit agencies and cities are facing the same issues as we are and to hear the strategies, such as security and community partnerships, they are implementing.

iii. Financial Statements for September 2025

The RC ratio was noted as remaining stable even with the service improvements that were made in September.
